

ANTIQUES2GO - TERMS & CONDITIONS

1. In these Terms & Conditions:-

Booking Form	<i>means</i>	the Booking Form attached to these conditions.
Stallholder	<i>means</i>	the Person named on the Booking Form.
Antiques2Go	<i>means</i>	Antiques2Go at the address overleaf
Lampport Hall	<i>means</i>	Lampport Hall, Lampport, Northants NN6 9HD

- Antiques2Go reserves the right to cancel the event at anytime in which case full reimbursement will be made to the Stallholder. Antiques2Go will not be responsible for any loss of earnings.
- Submission of a Booking Form together with payment of the amount due for the stall is deemed to be a booking by the Stallholder even if the cheque has not been cashed. Antiques2Go reserves the right not to accept a booking, in which case payment would be returned.
- If the Stallholder cancels the booking before the event then Antiques2Go will attempt to re-let the stall and refund the amount paid, less a £20.00 administration fee, however, if the stall cannot be re-let then there is no guarantee of a refund. **No refund will be made in the event of a cancellation by the Stallholder within one month of the event.**
- The stall area will be secured overnight but neither Antiques2Go nor Lampport Hall accept any responsibility for loss or damage to property at any time; the Stallholder is responsible for the insurance of their own goods.
- Antiques2Go reserves the right to move stall areas and re-allocate stalls as necessary. Every attempt will be made to position a stall as booked, Stallholders will be advised if the position requested is unavailable and will be offered an alternative.
- Lampport Hall provides one 13 amp socket to each stall. One table and one chair are provided for single stalls and two tables and two chairs are provided for double stalls. If space allows within your allocated stall area then extra tables and chairs may be rented at a cost of £5 per table and £2 per chair - or you can bring your own. The Stallholder must provide their own lighting, which must comply with all safety regulations and be safe to plug into the electricity supply – ie no broken plugs or sockets, wires hanging out, or duplicated wires in the same plug. At no time can any gangways be blocked by stock, tables or chairs, and all fire exits must be kept clear at all times. 13 amp sockets are provided for stall lighting only. Outside stalls are not provided with electricity. **No electric kettles or heaters are allowed – any stallholder using these items will not be allowed to re-book. The electrical supply is not sufficient for the use of halogen bulbs so please use only normal bulbs or low voltage (12v-24v) halogens.**
- Lampport Hall will allow the Stallholder access to the site to set up their stall at the times and dates shown on the Booking Form. Antiques2Go staff will be available during all set up and opening times.
- Antiques2Go allows the Stallholder to sell only goods as described on the Booking Form which must fit into the category of Antiques and Collectables. **Please do not use “Sale” signs on your stall** as it is against the law to offer products at Sale price unless they have been offered at full price at the same venue for a period of at least 28 days within the last 6 months. Lampport hall reserve the right to remove any exhibitor from the show if their pattern of trading and behaviour are deemed inappropriate.
- All vehicles must be moved to the parking area no later than 9.00 am on fair days and must remain in the car park until at least 4.30 pm. Vehicles can park close to their stall for loading and unloading.
- Stallholders **must not** begin to pack away items from their stall before the end of the Fair at 4 pm.
- Please note that the stallholder is responsible for the safety of their own stand, stock and equipment and the risks it may cause to others within their allocated space or immediate surrounding areas. By signing this form you agree that you have public liability insurance in place to cover these risks and agree to indemnify Lampport Hall and Antiques2Go in respect of any claim(s) arising from the presence of such equipment, operators, goods, vehicles and property at the event.**
- There is no heating at this Antiques Fair so please dress warmly.**
